In the equity commitment letter, the fund commits to the acquisition vehicle that it will invest equity in the vehicle at the closing of the transaction.

Equity Commitment Letter | Practical Law

A commitment letter (also called a mandate letter) to be sent by a bank to be appointed as an arranger and underwriter to a borrower in relation to a proposed syndicated facility. It sets out the terms on which the arranger will arrange and underwrite the loans or other facilities to be made to a borrower. The borrower grants the mandate by signing and returning the letter.
