Both parents can enroll/dis-enroll, both can pick-up, and both can authorize (or prevent) others to pick-up. However, if the father never established paternity or any other legal relationship to the child, and the parents were not married when the child was born, then the only person with custody rights is the mother.

A family child care home may be classified as large or small, depending on how many children are cared for. The number of infants and toddlers that can be cared for in a family child care home is often limited. Depending on the rules in your state, family child care providers may or may not be required to be licensed. Licensed providers are required to follow a set of basic health and safety requirements.

On August 31, 2020, Governor Newsom signed into law AB 3088 which protects renters facing financial hardship because of the coronavirus pandemic –including family child care home providers—from being evicted over any missed rent from March through August 2020. Under this eviction “moratorium,” you are expected to pay 25% of your total rent between September 2020 and January 2021, with the rest becoming “civil debt.”
